Professional Development provided for Teachers

Maxwell Unified School District provides one day of professional development to all certificated employees each year and monthly collaboration minimum days. New teachers are provided support through the TCIP (Tri-County Induction Program) with a district Mentor Teacher and county support meetings. In-service includes computer technology training, professional development on the California Standards, classroom management strategies, and differentiated instruction strategies. All teachers are encouraged to attend conferences and workshops and share their information with the other staff. Teachers returning from additional training are supported through additional funding to implement new methodologies.
